DBS Group Holdings (SGX: D05) has once again successfully engaged another round of strong bullish run based on our report on 3^{rd} November and 17^{th} November. Updated technical suggest that the bull run is yet to finish and may edge beyond \$27.00.

- Although the sub-impulse wave has complete for wave Y after price reached the high of \$26.00, which is also quite near to the 161.8% extension level of wave W and X. But the formation of the pennant may indicate further bullish continuation.
- The morning star formation is well supported above \$25.00 psychological level. Backtracking a few periods, the pin bar on 1st December is also well supported above \$25.00 after a bearish engulfing candle. Hence it looks like a mini bottoms.
- 3. The bullish golden cross is still well intact as prices is still trending far above the 200 and 50-day moving averages.
- 4. RSI shows a rebound at RSI 60 support line after a bout of oversold. However, there is a risk of a negative failure swing, which may bring the stock officially lower should that happen.
