Hi-P Ltd - Daily timeframe (Update from 16 August 2017)

Current Sentiment: Bullish

Support 1: 1.280 Resistance 1: 1.500 Support 2: 1.170 Resistance 2: 1.550

Price experienced some correction after the last update as the 1.500 psychological round number resistance continued to cap the bullish momentum. Nonetheless, the uptrend remains intact as the confluence of 38.2% Fibonacci retracement level, 20 day moving average and 1.280 support area stood ready to halt the correction. Price is still forming a series of higher highs and higher lows.

There were three attempts to break below that support area since 28/08/17, but all attempts failed miserably showing the significance of the 1.280 support area. Moreover, the recent bullish rejection off the support area succeeded in breaking price above the 20 day moving average and downtrend line forcefully with increasing volume on 02/10/17 suggests the resumption of the uptrend next.

Expect price to rise next to test the 1.500 psychological resistance area followed by 1.550.
