Price rose as expected after the last update and after testing the 0.250 psychological resistance area, an immediate top was formed at 0.260 high on 04/05/17. Since then, a significant correction took over which lasted for 24 weeks.

Price seemed to have found a strong base off the confluence of 50% Fibonacci retracement level and 0.150 resistance turned support area recently since 20/10/17. After testing the support area, price made a strong rebound with increasing volume and essentially halted the correction. Moreover, the subsequent bullish follow through resulted in price breaking and closing above the downtrend line and 20 week moving average on the week ended 24/11/17 signals the resumption of the uptrend.

Expect price to head back into the long-term uptrend next to retest the 0.210 resistance area followed by 0.240.
