EASTSPRING INVESTMENTS UNIT TRUSTS – ASIAN BALANCED FUND (THE "FUND") PROPOSED CHANGE TO THE UNDERLYING EQUITY FUND OF THE FUND

OUTCOME OF EXTRAORDINARY GENERAL MEETING

We thank you for your continued support in the Fund.

We refer to the circular dated 1 March 2016 in relation to the extraordinary general meeting held to consider the proposed change to the underlying equity fund of the Fund on 31 May 2016 or such other date as we may, in consultation with the Trustee, determine.

As manager of the Fund, we wish to inform you that the extraordinary resolution to change the underlying equity fund of the Fund and to amend the Trust Deed to reflect the change was passed at the extraordinary general meeting held on 22 March 2016.

Accordingly the underlying equity fund of the Fund will be changed to the Luxembourg domiciled Eastspring Investments – Asian Equity Income Fund. In consultation with the Trustee, we have determined that we will start to effect this change on <u>23 May 2016</u>. We anticipate there will be a transition period after 23 May 2016 before the Fund is fully invested into the new underlying equity fund, Eastspring Investments – Asian Equity Income Fund.

In view of the upcoming change to the underlying equity fund of the Fund, we and the Trustee shall be authorised to take all such steps as we and the Trustee may consider necessary, desirable or expedient, in order to give effect to the extraordinary resolution which has been passed.





Options available to you

Option 1 – Continue to hold

You may continue holding your Units, in which case, **<u>no action</u>** is required on your part.

Option 2 – Switch

Should you choose not to continue holding your Units, you have the option to switch your holdings into another fund managed by Eastspring Investments (Singapore) Limited.

You may only switch into a fund which is available from your distributor. Therefore you should check with your distributor which funds are available on their platform.

If you had invested into the Fund using monies from your CPF Ordinary Account or CPF Special Account or your SRS Account, please note you can only switch into another fund that is eligible for investment using monies from CPF Ordinary Account, CPF Special Account or SRS Account respectively.

We will waive the switching fees over a period from 18 April 2016 to 20 May 2016 for switches into funds listed in Appendix A.

Your instruction to switch must be provided to your distributor by <u>3.00</u> <u>pm Singapore time on 20 May 2016</u> in order to enjoy the switching fee waiver. Switching instructions received after this time will not be eligible for the switching fee waiver.

Option 3 - Redeem

Should you choose not to continue holding your Units, you may redeem your holdings based on the prevailing net asset value of the Units. There is no redemption fee payable upon redemption.

Any transaction charges incurred with the CPF agent banks for switches and redemptions will be borne by you.
