Investment Strategy Changes for Six Allspring Funds

The Board of Directors of the Allspring (Lux) Worldwide Fund has approved modifications to six Allspring Funds, as detailed below. These changes are captured in a shareholder notice mailed to investors on 4 September 2023 and will be effective on 4 October 2023.

Allspring continually monitors and reviews its products' performance and competitiveness versus market peers, and these changes are designed to enhance each of the funds in these areas. Note that as part of these changes, the U.S. Select Equity Fund will change its classification under the Sustainable Finance Disclosure and Taxonomy Regulations to Article 8.

Emerging Markets Equity Fund

- With respect to the fund's purchase restriction for securities of companies deemed to be in breach of UNGC principles, create an exception for companies where the breach was primarily a result of government regulation and interference beyond the control of the issuer
- Clarify that at least 64% of fund assets will be invested in companies determined to either have: 1. strong
 current performance on environmental, social or governance (ESG) issues tied to long-term value creation
 or 2. improvement catalysts in place demonstrating that they are on track to meet improvement
 expectations around ESG issues tied to long-term value creation

Emerging Markets Equity Income Fund

- Update the sustainability-related exclusionary policy to be more aligned with the dynamics of the emerging markets and consistent across Allspring's emerging market equity funds
- A copy of the methodology used to assess, measure and monitor the environmental or social characteristics of issuers and list of excluded investments (including the revenue thresholds) is available on our website here.

Global Equity Enhanced Income Fund

- Clarify that at least 90% of assets will be invested in equity securities of companies located worldwide of which at least 90% will be invested in dividend-paying equity securities
- Clarify that the fund seeks to provide a targeted yield based on prevailing market conditions, although there is no guarantee the fund will generate the targeted yield or any other level of income or returns

Global Small Cap Equity Fund

- Benchmark change from S&P Developed Small Cap Index to the MSCI World Small Cap Index used for performance comparison and to define the market capitalisation of small-capitalisation companies
- Clarify that at least 64% of fund assets in companies that are perceived as strong ESG performers or companies with underappreciated ESG characteristics that can drive future growth consistent with the sub-investment manager's forward-looking expectations

U.S. All Cap Growth Fund

Clarify that at least 64% of fund assets will be invested in companies that are perceived as strong ESG
performers or companies with underappreciated ESG characteristics that can drive future growth
consistent with the sub-investment manager's forward-looking expectations



U.S. Select Equity Fund

- Modify the fund's investment strategy to add the following:
 - o Invest at least 64% of fund assets in shares of companies with strong ESG performance tied to the durability of their business model or companies with ESG improvement catalysts in place and demonstrating that they are on track to meet improvement expectations around environmental and/or social issues tied to the durability of the business model. Such ESG performance may be in the form of environmental and social policies, products, and/or practices that contribute to a durable business model.
- Apply Allspring's "core" set of exclusions and additional negative screening criteria
- As a result of the above changes, the fund will change its classification under the Sustainable Finance Disclosure and Taxonomy Regulations to Article 8.
