– REMOVAL OF BENCHMARK**

Thank you for your support for the Nikko Asset Management Asia Limited family of funds.

This letter serves as a notice only and no further action is required from you.

We, the managers of the Fund, wish to inform you that with effect from 1 November 2017 (the “**Effective Date**”), the current benchmark for the Fund (i.e. Straits Times Index (STI) (the “**Benchmark**”)) will be removed and there will no longer be any benchmark for the Fund. This is because pursuant to the investment objective of the Fund, the Fund is managed on a total return basis and as such, it does not seek to outperform any benchmark.

The removal of the Benchmark with effect from the Effective Date will be reflected in an updated prospectus for the Fund (the “**Prospectus**”) to be registered by the Monetary Authority of Singapore (the “**Authority**”) on or around 26 October 2017. After the registration of the Prospectus by the Authority, electronic copies of the Prospectus will be available at www.nikkoam.com.sg and you may obtain hard copies of the same, where available, from our approved distributors.

Please note that the current investment objective, focus and approach of the Fund will remain unchanged.

You should consult your financial adviser or distributor if you have any doubt as to whether this notice will have any potential impact on your decision to continue to invest in the Fund.

Please contact the distributor from whom you originally purchased your units in the Fund if you have any queries in respect of your investment in the Fund.
