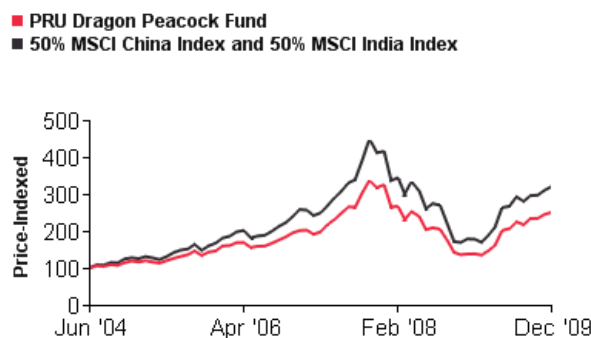

Performance Chart


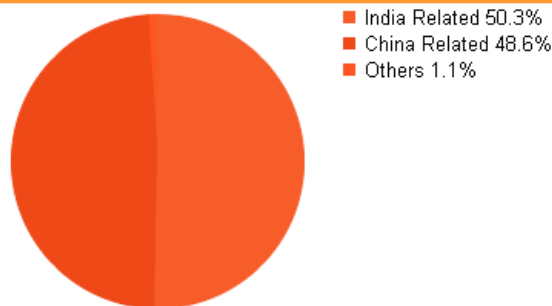

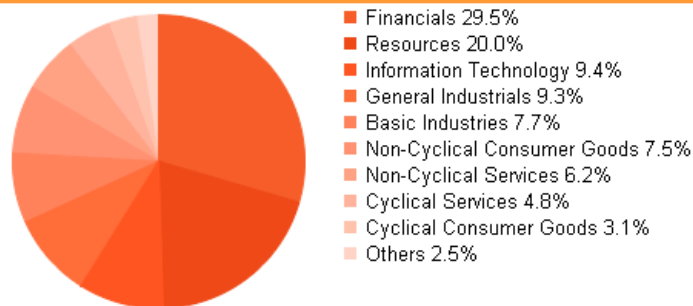

Market Overview

The MSCI India Index advanced 3.5%¹ in December. IT, materials and industrial sectors were relative outperformers while consumer staples and financials underperformed. Sentiment for the IT sector was bolstered by positive economic data releases in the U.S. while improvement in the global growth outlook for 2010 helped base metal and materials prices. Financials underperformed on expectations of an interest rate increase while consumer staples underperformed on concern over the impact of higher raw material prices. The MSCI China Index inched up 0.5%¹ in December, its fourth consecutive month-on-month advance with IT leading advancers and healthcare falling. Premier Wen Jiabao aimed to ease investor worries that China would not end the stimulus policies too soon. The Fund advanced 2.4% (bid-to-bid basis), underperforming its benchmark return of 3.4%.

The leading contributor to performance in December was Focus Media. The company is positioned well to benefit from an advertising rebound and the shedding of its under-performing assets. AAC acoustic has had a remarkable year with impressive share wins with major handset manufacturers. Improvement in the global growth outlook for 2010 helped base metal prices and materials stocks such as Hindalco Industries. China Zhongwang Holdings Ltd, a manufacturer of aluminium extrusion products, was an exception and shares were impacted by negative media reporting. Shares of GVK Power and Infrastructure declined on the back of potential new regulatory restrictions regarding merchant power sales. We believe this may be an overreaction. IVRCL Power & Infrastructure enjoyed a solid order book that provided forward visibility but funding constraints could increase the near-term risk of execution which led some investors to be cautious. Infrastructure Development Finance declined in December as investors took profits following a healthy run. We exited China Life Insurance in favour of China Pacific Insurance. China Pacific enjoys better operating trends, more growth drivers and appealing valuation.
