

Aberdeen Global Opportunities Fund



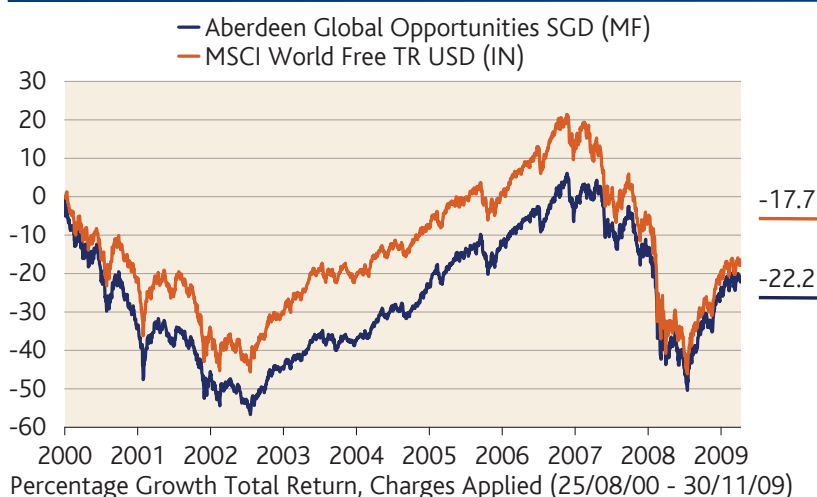
Fund objective

Fund manager's report

- Global stockmarkets rose in November, as most leading economic indicators continued to improve, despite a late sell-off because of debt problems in Dubai. North America outperformed emerging markets during the month.
- Regulators are increasingly concerned about the risks of asset bubbles: Brazil and Taiwan imposed measures to stem the inflow of hot money. Amid escalating property prices, China urged banks to be rational in lending to real-estate companies.
- Divergent policy moves underlined the headwinds faced by central banks. The ECB is considering withdrawing stimulus measures and Australia raised interest rates for the second month in a row. In contrast, Japan will inject further liquidity into the banking system.
- We sold our holding in Bank of Yokohama, given persistently tough conditions in the Japanese banking sector. With the proceeds, we added to insurer Zurich Financial Services, US pharmacy group CVS Caremark and Japan's Shin-Etsu Chemical.
- The continued rise in global equity markets makes us increasingly cautious on valuations. Conditions will remain difficult as companies contend with anaemic levels of final demand.
