Fund Commentary - PIMCO Emerging Markets Bond Fund

Investment Objective

The Fund invests at least 80% of its assets in fixed income instruments of issuers that are tied to emerging securities markets.

What happened in the market

In spite of continued concerns over peripheral Europe, Emerging Markets (EM) managed to return 2.01% in June 2010 as measured by the JP Morgan Emerging Markets Bond Global Index, recovering the 1.58% loss in the previous month. Amid increased credit differentiation, higher quality credits outperformed with a 2.23% return. BB and B rated credits followed with returns of 1.73% and 1.59% respectively. Latin America and Africa outperformed, returning 2.90% and 2.05% respectively. Asia and EM Europe followed with returns of 1.51% and 1.16% respectively. The Middle East lagged with 0.86%.

Outlook and strategy

Growth in EM countries is likely to be relatively robust compared to the developed world. Emerging economies, especially China, should continue to grow at a faster pace. PIMCO will retain structural allocations to higher rated countries with solid fundamentals.
