We, HSBC Global Asset Management (Singapore) Limited ("AMSG"), are the appointed Singapore Representative of HSBC Global Investment Funds and HSBC Portfolios ("Umbrella fund(s)") where certain sub-funds under the Umbrella fund(s) are registered as Recognised Scheme(s) in Singapore.

We are writing to inform you that certain share classes ("Share Class(es)") of the sub-fund's(s') of the Umbrella fund(s) will be de-registered from Recognised Scheme with effect from 16 September 2024 (the "Effective Date"). As part of our periodic review of product offerings, these Share Class(es) has(have) been identified due to minimal assets raised. As such, we believe that it is in the interest of its(their) shareholders to proceed with the de-registration exercise to achieve operational and cost efficiency.

For the impacted Recognised Scheme's(s') share classes, please refer to the Appendix.

You do not need to take any action. However, you do have three options that are explained below.

Your Options

- 1. Take no action. You can continue to hold your investments.
- 2. Convert your investment to another HSBC Global Investment Funds or HSBC Portfolios sub-fund. If you wish to ensure the conversion is completed before the changes become effective, instructions must be received before 4:00 pm Singapore time on the dealing day prior to the Effective Date as given in the right-hand column.
- **3. Redeem your investment.** If you wish to ensure your redemption is completed before the changes become effective, instructions must be received before 4:00 pm Singapore time on the dealing day prior to the Effective Date as given in the right-hand column.

Options 2. and 3. may have tax consequences. You may want to review these options with your tax adviser and your financial adviser.

Regardless of which option you choose, you will not be charged any conversion or redemption fees by HSBC for options 2. or 3. However, please note that some distributors, paying agents, correspondent banks or intermediaries might charge switching and/or transaction fees or expenses at their own discretion.
